# Be the Best Reporter You Can Be!

### **Work Smarter, Not Harder**

Change the icons of your file folders on your computer. It makes them stand out and easy to find.

Have a folder you need to stay at the top of the list? Rename with 1 (or 111) in front of file folder name.

Set up Quick Access for those folders you go to continuously.

What if ... you dropped your laptop after your job or someone snatches your bag on the way to your car and your files are gone!

Solution: Immediately upon conclusion of your job, back up your files to the cloud via Google Drive, Dropbox, OneDrive, your software cloud, whatever you want to use.

#### **Zoom Tip**

Tired of seeing participants turn into 1-inch squares during screen share?

Use an external monitor and choose "extend display" in Windows settings and click dual monitor option in Zoom settings. This enables you to see your speakers on one screen and the exhibits on the second screen.

During no screen share you can have speaker view on one screen and gallery view on the other. Now you can see the person speaking on one whole screen.

Want to make quick edits during a pause in testimony without having to reach up to your laptop keyboard?

Use a mini keyboard and set it on top of your writer screen with a piece of nonstick cabinet liner between keyboard and screen. It's a game changer!

Do you have a brief for ....

#### Amy's comments about LHPS and RHPE:

It has taken me many months to learn but so worth it. Start with one or two. Many of these I had to memorize that shape instead of the letters. Learn them in shapes if the letters don't stick. Put the shape on an index card with the word on the back. These are just suggestions. If you have a conflict, find something else that works. I love to use my number bar as a wild card so to speak for any brief that is a conflict.

## **Notary News**

As most of you are aware, we are still at a standstill with our remote oath notarization (RON) as of the time of this newsletter. RON laws have been enacted in 38 states, with legislation currently pending in additional states and the U.S. Congress. NCCRA has, fortunately, been able to partner with other members of a coalition that have a vested interest in the RON becoming permanent, i.e., transactional attorneys, mortgage industry participants, court reporters and other notaries. House Bill 776 passed the House 107-1 with favorable language. The bill is now before a Senate subcommittee. If passed, it will allow us permanent remote oath notarization, as well as transboundary remote notarization authority. Unfortunately, we don't have an exact timeline of when the committee will meet and/or when this will go for a vote, but we are expecting it to be considered this year.
