Speaker Bios



LERRYN HORTON ROBERDS, RPR, AZ CCR, attended Legal Arts of Arizona, a premier court reporting school in Phoenix, Arizona, graduating in 1982. Upon completion of school, Lerryn traversed the country to work for the State of Maine Courts assigned to the circuit court northern district traveling from Bangor north to Caribou. After two years traveling the circuit in Maine to the most remote and historic courthouses imaginable, Lerryn was contacted by the Honorable Barry DeRose in Gila County, Arizona, and asked to “Come Home”. That began the stint in the Arizona Superior Courts where Lerryn spent the next 18 years covering Superior Courts in seven counties. In 1999, Lerryn made a change and started Performance Reporters in Flagstaff, Arizona, and continues to work as a freelance Court Reporter traveling the vast area of Northern Arizona and the most unique assignments one could imagine.



MIKE WATKINS started his court reporting career in 1991, when he began working in Jasper, Alabama for Walker County Court Reporting. From there he moved to Florence, Alabama, to work with Clark and Bishop Court Reporting. He stayed on with Bishop Court Reporting until 1995 when he began an officialship for Lauderdale County, Alabama. There he worked for Judges Don Patterson, Alice Martin, and Mike Jones.

In 2000, he moved to the Upstate of South Carolina, where he worked in Charlotte, freelancing with the firm of Adams and Holt. In 2002, Mike realized he missed the courtroom and applied to the State of South Carolina to be an official court reporter, and he held that position until March of 2024 when he resigned to file to run for the office of Clerk of Court of Lancaster County, SC. He was elected November 5, 2024, and was sworn in on January 2, 2025.

In the last 21 years, Mike has worked several high profile cases, two of which were State versus Jamie Baldwin (featured on Dateline) and the State versus Alex Murdaugh (featured on Court TV, Netflix, Dateline, 20/20, and others.)



KRISTY CLARK, RPR, CRR, CSR

Kristy Clark began her court reporting career in August of 2001 in Las Vegas, Nevada, where she spent her first 10 years doing primarily freelance deposition work. During her last seven years in Las Vegas, she worked with a judge covering medical malpractice, personal injury, breach of contract, and construction defect trials and providing the judge with a daily real time output. This trial work enabled her to begin providing real time and daily transcripts for a firm covering federal trials across the country. In 2018, Kristy moved to Charlotte, North Carolina, and has been covering freelance deposition work as well as still traveling to cover federal trials. Also, during her career in Nevada, she served on the Nevada Court Reporters Association for 10 years in various positions, including president. Kristy also served on the NCRA TRAIN Committee in 2014 and has attended annual NCSA meetings as the Nevada delegate. Currently she holds her RPR, Nevada CCR, California CSR, as well as Notary Public for the states of Maryland, Virginia, Washington DC, and North Carolina.

PHYLLIS CRAVER LYKKEN, FAPR, RPR, CSR

Phyllis Craver Lykken began her reporting career in 1980 as a freelance reporter. She is a former firm owner. She holds the nationally recognized certification of Registered Professional Reporter (RPR), and is certified to practice in WA and OR. She is a Fellow of the Academy of Professional Reporters (FAPR). At the national level, Craver Lykken served as chair and member of the National Court Reporters Association (NCRA) STRONG Committee. She has served on numerous other NCRA committees, on the National Congress of State Associations Governing Board, as an NCRA Regional Representative, and on the NCRA Board of Directors. She's presented at NCRA's Annual Conference & Expo, numerous webinars, and multiple state association seminars. She was one of the authors of NCRA's White Paper on the risks emerging surrounding the use of AI/ASR in legal settings. At the state level, Craver Lykken has held many positions with the Washington Court Reporters Association (WCRA), including serving as president on three occasions and co-president once. She's been a fierce legislative advocate, serving as WCRA's Legislative Committee Co-chair for many years. She once appeared before the Washington Supreme Court (WSC) to brief a proposed court rule amendment. She played an instrumental role with WCRA, the Washington State Bar Association (WSBA), and the WSC in enacting an emergency order to allow for remote oath administration during COVID. In addition, she was appointed by the WSC to serve on the WSBA Character and Fitness and Limited Licensed Technician (LLLT) Boards.



DEBBIE DIBBLE, FAPR, RDR, CRR, CRC, CSR/CCR

Debbie has been serving our profession for over two decades on a state level and national level, serving as the 2021-2022 president of NCRA. During those years she has been a sought-after speaker for state associations, national leadership events, as well as legal bar and paralegal associations sharing information gathered during her participation in national and state platforms invested in researching the impacts and risks being promulgated by the undocumented and unchecked use of artificial intelligence and digital recording that is depriving citizens of their rights, risking the accuracy of the record, and jeopardizing justice.

Sue presently serves as an official court reporter in the Common Pleas Court of Xenia, Ohio. She has chaired and served numerous NCRA committees and task forces, including Technology Evaluation, Discover Steno, Nominating, Finance, Distinguished Service Award, Education Content, TRAIN Task Force, Communications and Outreach, and numerous additional task forces. Sue chaired the NCRA STRONG Committee, the authors of the NCRA White Paper. She has served on the Gigatron Advisory Committee, the SUN Liaison Committee, Thomson Reuters Livenote Advisory Committee, and is a frequent presenter for the National Court Reporters Association, Ohio Court Reporters Association, the Ohio Supreme Court, bar and paralegal groups, and many state court reporting associations. Sue is a Registered Professional Reporter, Certified Realtime Reporter and Certified Realtime Captioner. She has received the distinction of being inducted as a Fellow of the Academy of Professional Reporters.
